## REAR ADMIRAL THOMAS R. FOX, UNITED STATES NAVY COMMANDER NAVAL TRAINING CENTER

Rear Admiral Fox attended the Naval Academy, graduating with the class of 1957. He was assigned to naval flight training, earning his wings in December 1958. As a Naval Aviator, he served with All Weather Fighter Squadron FOUR (VFAW 4), Utility Squadron TWO (VU 2), and Fighter Squadron ONE SEVEN FOUR (VF 174). In 1962, he was assigned to duty in USS ALSTEDE (AF 48).

Rear Admiral Fox entered the Submarine Service in 1964. Since then, he has served in USS THOMAS JEFFERSON (SSBN 618), USS GEORGE BANCROFT (SSBN 643), and USS GEORGE C. MARSHALL (SSBN 654). He commanded USS GEORGE C. MARSHALL (BLUE), USS ETHAN ALLEN (SSBN 608), USS KAMEHAMEHA (SSBN 642), and USS PROTEUS (AS 19). Prior to commanding USS PROTEUS, he served as Assistant Chief of Staff, Personnel, Readiness and Training for Commander, Submarine Group FIVE.

He reported to Bangor, Washington in October 1980, and became Commander, Submarine Squadron 17, the first TRIDENT Submarine Squadron, on 1 January 1981 followed by Commander, Submarine Group NINE on 1 July 1981.

Rear Admiral Fox reported as Deputy Director, Strategic Submarine Division (OP-21) in the Office of the Deputy Chief of Naval Operations (Submarine Warfare) in September 1982. In November 1983, he took over as Director, Strategic Submarine Division (OP-21). He assumed his present duties as Commander, Naval Training Center, Orlando, on 31 May 1984.

He wears the Legion of Merit with Gold Star, Meritorious Service Medal with Gold Star, Navy Commendation Medal, National Defense Medal, Battle Efficiency Award, and the Sea Service Deployment Ribbon. Having completed seventeen strategic deterrent patrols, he also wears the SSBN Deterrent Patrol Insignia.

Rear Admiral Fox is married to the former Evelyn Kauffeld of South Tom's River, New Jersey. They have three children.



Captain Alfred M. Koster, a native of Vermillion, South Dakota, graduated from the U.S. Naval Academy in June 1957. He served in the destroyer, USS CHEVALIER (DDR-805), after commissioning until entering Submarine School in January 1959. Subsequent shipboard assignments included diesel submarines USS TENCH (SS-417), USS SALMON (SS-573) and USS REMORA (SS-487), before commanding USS TUSK (SS-426) in 1971 and 1972. Deployed operations aboard these ships included extensive periods in the Western Pacific and Eastern Atlantic/Mediterranean areas. Recent staff assignments have included tours as Prospective Submarine Commanding Officer Instructor, 1972-1975; Recent staff assignments have included tours as Prospective Submarine Commanding Officer Instructor, 1972-1975; Intelligence Officer for the U.S. Mediterranean Submarine Force, 1975-1978; and Submarine Operations Officer for U.S. Naval Forces in the European Area, 1978-1981. Captain Koster is a graduate of the Defense Intelligence School and the Naval War College. He holds a Masters Degree in International Relations from the George Washington University.

Captain Koster has been awarded the Meritorious Service Medal (two awards), Joint Service Commendation Medal, Navy Commendation Medal (two awards), the Navy Achievement Medal, and the Navy Unit Commendation for service at sea and ashore.

He is married to the former Agnes Louise Turner of Groton, Connecticut. They have three married children, Cris, Douglas and Susan.




